**BY SIGNING THIS RELEASE YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY**

To: \*Coast Mountain Snowboard Camps Ltd. dba Whistler Summer Snowboard Camp (hereinafter collectively referred to as Camp)

I am aware that participation in the camp involves skiing, ski instruction, snowboarding, snowboard instruction, cycling, in-line skating, skateboarding, trampoline, paintball, tennis, bungee jumping, swimming, windsurfing, whitewater rafting, wakeboarding, golfing, horseback riding and other similar activities. I am also aware that these activities involve inherent risks, dangers and hazards, including but not limited to: boarding, riding and disembarking ski lifts; failure of ski lifts; changing weather conditions; variation or steepness in terrain; exposed rock, earth, ice, trees or other natural objects; the condition of the snow or ice beneath the skiing surface; variation of the terrain used for skiing, snowboarding, cycling, in-line skating, windsurfing or any other sport; impact or collision with lift towers, natural or man made objects, motor vehicles, equipment, pedestrians, cyclists, other skiers or snowboarders, in-line skaters or any other object or person; negligence on the part of the Camp or their staff; and negligence on the part of other camp participants or other persons. I am aware that the risks, dangers and hazards referred to above exist throughout and off of the Camp's premises and that many are unmarked. I freely assume and fully accept all such risks, dangers, and hazards and the possibility of personal injury, death, property damage, or loss resulting therefrom.

In consideration of the Camp permitting my or my child's participation in the camp, I hereby agree as follows:

- 1) TO WAIVE ANY AND ALL CLAIMS that I may have against the Camp and all their directors, officers, employees, agents, and representatives (all of whom are hereinafter referred to as the RELEASEES);
- 2) TO RELEASE THE RELEASEES FROM ANY AND ALL LIABILITY for any loss, damage, injury or expense that myself or my child, or that my next of kin may suffer as a result of his/her participation in the Camp, and the use of any rental equipment, due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;
- 3) TO HOLD HARMLESS & INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to any third party resulting from my or my child's participation in this camp;
- 4) That this release of liability shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns in the event of my death.

I HAVE READ AND UNDERSTAND THIS AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING IT, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I MAY AND/OR MY CHILD MAY HAVE AGAINST RELEASEES.

I have also read and understand the cancellation policy including the section that outlines that there are no refunds after the camp start date for any reason (please note that if a camper is sent home for unacceptable behaviour, or is injured and not able to stay for the remainder of their session, we can not offer a refund).
